40 Years of Making a Difference!

Walter Redinger, a 65-year-old Ontario artist, was diagnosed with Parkinson's in the early 1990s. According to Walter, Parkinson's is a minor speed-bump on the road of life. He says there is something else besides Parkinson's. What is that thing?

"Life," says Walter defiantly.

Walter is just one of approximately 100,000 people living with Parkinson's in Canada. He and others like him are the reason Parkinson Society Canada and its Regional Partners exist. It is why we constantly look for new and better ways to provide support and hope to those we represent. This year we took a hard look at our financial position and came up with a forward-looking plan.

As a result, we

- continued to increase our investment in research currently, we can only fund one third of grant applicants;
- are developing, thanks to a generous bequest, a psycho-social research grant program to increase support for the "Ease the Burden" mandate of our mission;
- redesigned our website's home page to reflect the Pan-Canadian presence of PSC and its Regional Partners;
- improved the speed, timeliness and consistency of our financial reporting;
- improved management outcomes in Human Resources, Financial Management, Resource Development and Communications & Marketing - thanks to the professionalism and level of responsibility assumed by staff;
- developed/approved a budget to support organization development and our mission;
- worked to resolve the challenge of resource allocation ... progress has been slower than expected but our work this year will take us another step closer to sharing resources equitably.

We are pleased to report that 18,931 family physicians have been reached through our Medical Information and Support Program (MISP) to date. With the support of a generous corporate sponsor, PSC will reprint the MISP kit for distribution to the remaining family physicians across Canada and to neurologists.

Future plans for the Program include:

- expanding market penetration of the kit to ensure 100% of family physicians practising in Canada have the best tool kit available on Parkinson's;
- ensuring all components of the kit are available in English and French;
- updating the contents of the kit to include emerging information about the marked prevalence and impact of neuropsychiatry problems associated with Parkinson's such as cognitive impairment, hallucinations/delirium, behavioural impairment and depression.

We will continue, with your generous support and commitment, to make a difference each and every day in the lives of people living with Parkinson's, caregivers and family members!

It is a chronic progressive neurological disorder caused by a reduction of dopamine in the brain, affecting nearly 100,000 Canadians.

Symptoms include:

- A resting tremor
- · Difficulty with fine movement
- · Slowness and stiffness of muscles
- · Difficulty with balance and walking
- · Loss of volume and clarity of speech
- · Tendency to shuffle when walking
- Handwriting difficulty

Knowledge of symptoms, medication, exercise and therapy can help people maintain control over their Parkinson's.

PSC's National Research Program was launched in 1981 with the creation of its first Scientific Advisory Board. From 1981 to 2004, PSC has supported 166 Canadian or visiting researchers in single- or multi-year research projects and has invested more than \$10.7 million in Canadian Parkinson research and training. In the past three years alone, PSC has invested over \$2.1 million.

Modelled on the Canadian Institutes of Health Research's four pillars of research, PSC's program supports a broad range of applications - biomedical, clinical, health services and systems research and population studies. Our volunteer Scientific Advisory Board - comprised of Canada's top neurosurgeons, neuropathologists and neuroscientists - evaluates research proposals using a rigorous peer review process to support some of the most promising projects in Canada.

Achievements

- The 2nd annual Donald Calne Lectureship was awarded to Dr. Oleh Hornykiewicz of Vienna one of the world's leading neuroscientists. Early in his career, he determined that Parkinson's disease results from too little of one kind of neurotransmitter, known as dopamine. His subsequent development of L-dopa for the treatment of Parkinson's revolutionized treatment and remains the cornerstone of therapy today.
- 2004-2006 Awards: \$941,000 in new funding this year in addition to \$395,500 to support existing 2003-05 cycle awards in their second year
- Awards Breakdown: 10 new grants and 5 new fellowships 5 Pilot Project grants, 5 New Investigator grants, 4 Basic Research Fellowships and 1 Clinical Movement Disorders Fellowship
- Total Projects funded in 2004: 29 awards across Canada 15 new awards and 14 awards from the 2003-05 cycle
- Funding Increase: research commitment of \$1,063,750 represents a 27% funding increase over last year
- Clinical Assistance & Community Outreach Grants: 22 grants totalling \$240,000 went to clinical nurses to educate, support and be a resource to people with Parkinson's/care partners and community-based programs which provide direct care and services ... since its inception in 1990, PSC has supported these community-based programs with \$2.1 million in grants

New Research Commitment

Parkinson Society Canada and its Board of Directors have made a commitment to invest in prevention and care as proactive strategies to reduce the social and economic burdens of Parkinson's disease and the need for basic epidemiological research. In recognition of the need to provide funding and foster capacity building in this area of research, PSC is developing a program specifically focused on a Social & Psychological stream of research. It is anticipated that an announcement for the first award in this new category will be made in 2007.

Parkinson Society Canada (PSC) provides funding of healthcare services for people with Parkinson's across the country.

Academically-trained neurologists dedicated to the care of people with Parkinson's are supported through our Clinical Assistance Program which recognizes the invaluable service of a medical team within a geographic area of Canada. Funds (partial salary) go to a healthcare professional to provide ongoing support and services for people with Parkinson's right in their own community.

Our Community Outreach Grant Program supports community-based programs providing direct care and services to people with Parkinson's. It recognizes the expertise and dedicated efforts of specialized staff and helps them to achieve program objectives.

VIVRE AVEC LA MALADIE DE PARKINSON

Al Smith

Lorsqu'il a reçu son diagnostic de maladie de Parkinson en 1999, sa méconnaissance de cette maladie l'a effrayé bien davantage que la maladie elle-même. Al Smith avait été golfeur professionnel, conduisait une motocyclette dans ses temps libres et aimait jouer avec ses petits-enfants. Il s'est alors demandé s'il pourrait poursuivre ces activités et pendant combien de temps.

Il a réalisé que « la maladie de Parkinson est une maladie, et non une sentence de mort. C'est un obstacle sur un très long parcours. » Aux 100 000 autres Canadiens qui suivent ce parcours, il offre ce message : « Apprenez à connaître vos limites et ayez le courage de les dépasser. Je continue de jouer au golf et de conduire ma Gold Wing lorsque je le peux. Je joue avec mes petits-enfants et je vis pleinement ma vie. »

Alison Wood

Alison Wood avait 46 ans lorsqu'elle a remarqué pour la première fois le tremblement de sa main gauche. Trois ans plus tard, en 2003, elle a reçu son diagnostic de maladie de Parkinson. Elle alors craint que tout ce qu'elle avait planifié pour sa retraite - faire de la tapisserie, être joueuse de clochettes et donner des ateliers - soit affecté par le tremblement de ses mains. Elle était aussi préoccupée par la possibilité d'éprouver de la difficulté à parler, à sourire et à écrire.

Malgré ce diagnostic, Alison a choisi de faire tout ce qu'elle peut pendant aussi longtemps qu'elle le peut et de faire ce qu'elle aime. Elle a recommencé à enseigner à temps partiel et a accepté le poste de directrice administrative de l'International Hand Bell Committee. Elle chante avec les Richard Eaton Singers, chorale qui accompagne souvent l'Orchestre symphonique d'Edmonton. Grâce au D' Harold Wiens, professeur de musique étudiant les bienfaits du chant chez les patients atteints de la maladie de Parkinson, elle a appris que les leçons de chant renforceront sa voix.

« J'ai encore certaines craintes face à l'avenir et à ce que seront ma mobilité et mon indépendance, mais je suis heureuse, car je fais ce que j'aime et j'aurai de bons souvenirs à chérir. »

Marlene Nypiuk

En 2002, Marlene Nypiuk a couru son premier marathon pour célébrer son 60^e anniversaire de naissance. En mai 2005, elle a reçu son diagnostic de maladie de Parkinson. Sa première réaction fut la suivante : « Où me suis-ie trompée ? »

Maintenant retraitée après 28 ans comme sténographe judiciaire, Marlene continue de s'entraîner et de participer à des épreuves de course. En sortant de chez elle chaque matin, elle est reconnaissante de cette autre journée, de cette autre course. « Un jour, je ne ferai peut-être que marcher, mais présentement je cours. Jusqu'à présent, mes symptômes ne sont pas prononcés et je ne prends pas de médicaments. J'ai de bonnes journées - et de meilleurs jours. »

Marlene se concentre sur les choses qu'elle peut faire, plutôt que sur les activités qu'elle ne peut pas accomplir. La Parkinson's Society of Alberta lui fournit soutien et compassion, dit-elle. Lorsqu'elle est morose, Marlene se rappelle les paroles de John Bingham : « Le miracle, ce n'est de terminer, mais plutôt d'avoir le courage de commencer. »


Major Event

FINANCIAL ACCOUNTABILITY

June 1, 2004 - May 31, 2005: The Fiscal Year in Review

The past fiscal year was both rewarding and challenging for Parkinson Society Canada. We are a national organization with Regional Partners from coast to coast, working together to support Canadians living with Parkinson's.

Some Regional Partners are not yet self-sufficient. As a result, their operations are fully consolidated into Parkinson Society Canada's financial statements. The financial results represent the National office, Ontario (excluding Ottawa), the Maritimes, Manitoba, and Newfoundland & Labrador.

Summary - Fiscal 2005

- Gross revenue retained the 2004 level.
- Research, clinical and outreach grants of \$1,208,143 represent a 14% increase over last year.
- Operating and Administrative expenses were maintained at the 2004 level.

Revenue

Parkinson Society Canada's gross revenue was \$6.3 million. Bequest revenue (an unpredictable revenue source) was 41% less than the prior year. Gross revenue remained consistent - with a 10% increase in corporation donations, increases in research contributions and a 7.5% rise in individual donations.

74 communities across Canada took part in SuperWalk 2004 and raised a record \$1,680,000. (See Our Donors section for 2005 results.)

Expenditures

In fiscal 2005, \$3.2 million in research, education and services expenditures supported Canadians living with Parkinson's - up 16.5% from 2004.

Although Fundraising costs increased by 2%, gross revenue, excluding Bequests, increased by 10%.

Net Assets


Net assets were \$3.76 million at May 31, 2005 - an increase of 9% over 2004. Reserves, including an internally restricted research stability fund, are being maintained to ensure the delivery of our core National programs: research, education, advocacy and support services.

- Outstanding Year for SuperWalk for Parkinson's: The 2004 SuperWalk Campaign set a new record raising \$1,680,000, an 11% increase over 2003.
